*The scope of the present paper is to investigate the identity and the dynamics of the major criminal actors of the transnational and the international system as well as to analyze criminalism as an intrinsic and driving force of the established world order. Indeed, we maintain that, due to criminalism, not only is the border between the established world order and the contemporary underworld order blurred, but also there are organic channels of communication/collaboration between the social establishment and the underworld. In this context, we study the creation and global march of what we call here the “Black-Red International,” namely, a postmodern, global network of mobsters, political extremists/terrorists (transcending old dichotomies between the ‘Right’ and the ‘Left’), former spies associated with the historical Nazi and Soviet ‘deep states’ and their secret plans for world domination, autonomous subgroups of several nations’ secret services, and a group of complacently nihilistic businessmen who act as the financial facilitators of this “Black-Red International.” Since, in the beginning of the twenty-first century, the West entered into a state that the renowned French philosopher Myriam Revault d’ Allones has pointedly called a “crisis without end,” that is, a global crisis that affects finance, education, culture, the natural environment, and human relationships (see: M. R. D’ Allones, *La Crise Sans Fin: Essai sur l’**

Expérience Moderne du Temps, Paris: Seuil, 2012), and since the traditional Western bourgeois elites have become so corrupt that, as Lenin would say, are ready to trade even the rope with which members of the “Black-Red International” would hang them, it logically follows that the dawn of the twenty-first century signals a deep, existential crisis of civil democracy, liberalism, and humanism.

“Shadow elites”

In 2008, David J. Rothkopf, CEO and editor of the FP Group, which publishes *Foreign Policy* magazine, published his book *Superclass: The Global Power Elite and the World They Are Making*, in which it is claimed that the world is subject to the immense influence of an elite, namely, “the superclass” (D. J. Rothkopf, *Superclass: The Global Power Elite and the World They Are Making*, U.S.A.: Farrar, Straus and Giroux & UK: Little, Brown, 2008). In particular, David Rothkopf has referred to the illicit “shadow elites, those whose influence stems from illicit or unconventional means” (Ibid, p. 289).

Characteristic representatives of these “shadow elites” are the following: The arms dealer Adnan Khashoggi, who was once characterized as “the richest man in the world” (see: Ronald Kessler, *The Richest Man in the World: The Story of Adnan Khashoggi*, New York: Warner Books, 1988), and he was also listed in the 1992 Senate BCCI Report as one of the “principal foreign agents of the U.S.” (U.S. Congress. Senate, 102nd Cong., 2nd Sess. *The BCCI Affair: A Report to the Senate Committee on Foreign Relations from Senator John Kerry, Chairman, and from Senator Hank Brown, Ranking Member*, Subcommittee on Terrorism, Narcotics, and International Operations, p. 299). The Far West Ltd (later Far West LLC) network, which is a multinational network of members of the global organized crime, various national secret services, and business corporations. Vladimir Filin, the Russian leader of Far West LLC, which has recruited many former Soviet military intelligence officers, has been accused of arms and drug trafficking, and Valery Lunev, a former colonel of Belarusian special forces, who now lives in the Netherlands but regularly visits Belarus, became a senior officer of Far West, responsible for Far West’s black paramilitary operations, including the violent coup d’état of 1991 against Georgian Premier Zviad Gamsahurdia, in which at least 113 people died (source: Peter Dale Scott, “The Global Drug Meta-Group: Drugs, Managed Violence, and the Russian 9/11”; <http://www.lobster-magazine.co.uk/articles/global-drug.htm>). Furthermore, Valery Lunev offered militant-terrorist training to the Norwegian terrorist Anders Breivik, who caused mayhem in Norway on July 22, 2011 (source: Yuri Mamchur, “Norwegian Terrorist Anders Breivik Trained in Belarus Militant Camps,” *Russia Blog*, July 28, 2011). The Breivik manifesto and video associate Breivik with a network of neo-Templar crusaders who are militant proponents of their vision for a Judeo-Christian Europe (source: Paul Woodward, “Did Anders Behring Breivik Act Alone?” *Eurasia Review*, July 25, 2011).

In 2005, Peter Dale Scott, a former Canadian diplomat and English Professor at the University of California, Berkeley, wrote, in his article “The Global Drug Meta-Group: Drugs, Managed Violence, and the Russian 9/11,” the following: “Far West Ltd (now Far West LLC) is said to have CIA-approved contractual dealings with Halliburton for

geopolitical purposes in the Caucasus, as well as dealings in Iraq with Diligence LLC, a group with connections to Joe Allbaugh (the FEMA chief in 2001) and to the President's younger brother Neil Bush. The head of Far West recently told a Russian outlet that 'a well-known American corporation . . . is a co-founder of our agency,'" and he added that, "because of all these connections transcending normal political and ideological differences, I described it as a 'meta-group,' like the drug bank BCCI which was in some significant ways its predecessor" (source: <http://www.lobster-magazine.co.uk/articles/global-drug.htm>).

In the twentieth century, the West's financial system gave rise to a huge "financial bubble," which caused the 2008 global financial crisis. In 2008, the Bank for International Settlements (BIS), i.e. the central bankers' bank, 'slammed' the Fed, the European Central Bank (ECB), and other major central banks for blowing the "financial bubble" that caused the 2008 global financial crisis, failing to regulate the shadow banking system, and then using gimmicks which only worsen the financial situation (source: A. Evans-Pritchard, "BIS Slams Central Banks, Warns of Worse Crunch to Come", *The Telegraph*, 30 June 2008). On November 18, 2012, the Financial Stability Board (FSB), which was established after the 2009 G-20 London summit in April 2009, published its annual *Global Shadow Banking Monitoring Report*, in which it stated that, in 2011, the size of the total shadow banking system grew to \$67 trillion, which is equivalent to 111% of the aggregated GDP of all countries in the study; in 2011, the U.S. had the largest shadow banking system, with assets of \$23 trillion, followed by the euro area (\$22 trillion) and the U.K. (\$9 trillion), and, therefore, credit intermediation through non-bank channels had become a source of "systemic risk." The aforementioned speculative financial network is not only available to accept and launder black money (e.g., money from drug-trafficking, human-trafficking, arms-trafficking, and terrorism), but it is also vitally dependent on black money in order to have the minimum underlying assets that are necessary for aggressive speculative schemes and for the implementation of 'bail-out' programs, which give financial support to financial institutions that face serious financial difficulty or bankruptcy.

On November 6, 2011, in *The Huffington Post*, Janet Tavakoli, President of Tavakoli Structured Finance, published an enlightening article entitled "Fraud As a Business Model," in which she argued that "congressional investigations in recent years have put ample evidence of fraud in the public domain," and that "money is being put in taxpayers' pockets in the form of 'recoveries' while being extracted again in the form of subsidies and cheap funding to shaky banks that continue to award record pay and record bonuses as they gouge consumers."

Covert operations by autonomous former KGB networks

Anatoliy Mikhaylovich Golitsyn CBE (Russian: Анатолий Михайлович Голицын; born August 25, 1926), a Soviet KGB defector and author of two books about the long-term deception strategy of the KGB leadership, became an Honorary Commander of the Order of the British Empire (CBE) and, as late as 1984, an American citizen. Golitsyn worked in the strategic planning department of the KGB, and he attained the rank of Major. In 1961, under the name "Ivan Klimov," he was assigned to the Soviet

embassy in Helsinki, Finland, as vice counsel and attaché. He defected with his wife and daughter to the American CIA via Helsinki on December 15, 1961, and, in the U.S.A., he was interviewed by James Jesus Angleton, CIA counter-intelligence director.

In his book *New Lies for Old*, Anatoliy Golitsyn argues that a KGB elite network faked the collapse of the USSR, and, therefore, the official dissolution of the USSR does not mean that the 'deep' Soviet system was defeated. In 1961, after defecting to the West, Anatoliy Golitsyn told the CIA about a long-term deception strategy articulated by Soviet elite forces to lull the West and infiltrate the European countries and the USA. In this book, published in 1984, Golitsyn predicted the fall of the Berlin Wall which, indeed, took place five years later, in 1989. CIA counter-intelligence Chief J. J. Angleton took Anatoliy Golitsyn's intelligence and arguments seriously, but he was dismissed soon after, since many U.S. higher authorities found J. J. Angleton paranoid and a crazy conspiracy theorist.

Some of the most important pieces of intelligence that Anatoliy Golitsyn published in his book *New Lies for Old*, are the following

“When Soviet citizens were liberated from up to 74 years of horrific Marxist-atheist oppression on December 26, 1991, the day the USSR officially ended, there were ZERO celebrations throughout the USSR, proving (1) the ‘collapse’ of the USSR is a strategic ruse; and (2) the political parties of the West were already co-opted by Marxists, otherwise the USSR (and East Bloc nations) couldn't have gotten away with the ruse . . . the Kremlin staged anti-government demonstrations that took place in Russia (and other Soviet republics) in the years immediately preceding the ‘collapse,’ yet ZERO celebrations after the ‘collapse!’” Furthermore, according to Anatoliy Golitsyn, “the so-called ‘War on Terror’ is an operation being carried out by the Marxist co-opted governments of the West in alliance with the USSR and other Communist nations, the purpose being to (1) destroy the prominence of the West in the eyes of the world, where the West is seen (i) invading nations without cause; (ii) causing chaos around the globe; and (iii) killing over one-million civilians and boasting of torture; (2) close off non-Russian supplies of oil for export, thereby increasing the price of oil, the higher price allowing oil exporting Russia to maintain economic stability while she modernizes and increases her military forces; (3) destroy the United States Armed Forces via the never-ending ‘War on Terror’; the ultimate purpose of the aforementioned to (4) bring about the demise of the United States in the world, opening up a political void to be filled by a new pan-national entity composed of Europe and Russia (replacing the European Union), a union ‘From the Atlantic to Vladivostok’; which will (5) see the end of NATO.”

Furthermore, it is worth pointing out that a translational financial elite financed the masterminds of the Bolshevik Revolution, while simultaneously playing a protagonist role in the West's financial system, thus establishing covert organic channels of interaction and interdependence between the West and the Soviet system. In particular, the U.S. State Department, in its 3-volume report on the origins of communism in Russia,

published in 1931, reveals how Jewish-controlled German banks under the leadership of Max Warburg conspired as early as 1914 to send large payments to Lenin, Trotsky, and other Bolsheviks in their attempt to bring down the Tsar (see: United States Department of State, *Papers Relating to the Foreign Relations of the United States, 1918: Russia*). As part of this conspiracy, Jacob Schiff invested close to 20 million USD toward the establishment of Bolshevism in Russia, and he financed Trotsky's trip from New York to Russia (Jacob Schiff was born in 1847 in Frankfurt, Germany, to Moses and Clara Schiff. His father, Moses Schiff, was a broker for the Rothschilds. Jacob Schiff migrated to the United States after the American Civil War, and, from his base on Wall Street, he was the foremost Jewish leader from 1880 to 1920).

The network and the dynamics of the Russian Mafiya

Robert I. Friedman (November 29, 1950 – July 2, 2002) was an American investigative journalist. He is probably best known for his writings about violence-prone Zionist extremists and the book *Red Mafiya* about a notorious global criminal organization (see: http://www.goodreads.com/book/show/766497.Red_Mafiya). His writings provoked lawsuits and death threats throughout his career; he died on July 2, 2002 in Manhattan.

Robert I. Friedman describes the research behind his book *Red Mafiya: How the Russian Mob Has Invaded America* (Boston: Little, Brown and Company, 2000) as follows: "I ventured into the Russians' gaudy strip clubs in Miami Beach; paid surprise visits to their well-kept suburban homes in Denver; interviewed hit men and godfathers in an array of federal lockups; and traveled halfway around the world trying to make sense of their tangled criminal webs, which have ensnared everyone from titans of finance and the heads of government to entire state security services." Their racket involves heroin smuggling, weapons trafficking, mass extortion, and casino operation, among other activities. "Blending financial sophistication with bone-crunching violence, the Russian mob has become the FBI's most formidable criminal adversary, creating an international criminal colossus that has surpassed the Colombian cartels, the Japanese Yakuza, the Chinese triads, and the Italian Mafia in wealth and weaponry," writes Friedman. They have even penetrated professional hockey, as Friedman shows in an eye-opening chapter ("Federal authorities have come to fear that the NHL is now so compromised by Russian gangsters that the integrity of the game itself may be in jeopardy").

In the post-Soviet era, the Russian mob quickly became a major power in both Russia and the U.S. The Russian mob has now spread to every part of the United States, infiltrating its banks and brokerage firms; American law enforcement agencies have very lately woken up to this enormous problem. Very few journalists in the world know about the Russian mob in America as much as Robert Friedman did. At great risk to himself, he made connections with a number of top criminals. The result of his discoveries is a revelation: "the Red Mafiya is everywhere. The implications—for law enforcement, the economy, foreign policy, for the American people themselves—are staggering." It is worth pointing out, for instance, that, on May 22, 2016, the *Politico Magazine* published an article by David C. Johnston entitled "Just What Were Donald Trump's Ties to the Mob?" (see: <http://www.politico.com/magazine/about>). In that

article, Johnston wrote the following: Trump's career is based on his "dealings with top mobsters, organized crime associates," such as Salerno and Castellano and other mob families who "controlled both the concrete business and the unions involved in delivering and pouring it" as well as "the son of a reputed Russian mob boss whom Trump had at his side at a gala Trump hotel opening" and "Felix Sater, a senior Trump advisor and son of a reputed Russian mobster, whom Trump kept on long after he was convicted in a mob-connected stock swindle."

Furthermore, Jewish mobsters play a key role in the Red Mafiya, or the "Red Octopus," to the extent that the Russian Mafiya should rather be called the Judeo-Russian Mafia. Laura Radanko, herself Jewish, in her research on the Red Mafiya, writes the following: "During the detente days of the early 1970s, when Soviet leader Leonid Brezhnev had agreed to allow the limited emigration of Soviet Jews, thousands of hard-core criminals, many of them released from Soviet Gulags by the KGB, took advantage of their nominal Jewish status to swarm into the United States" (source: Laura Radanko, *The Russian Mafia in America*; <http://russianmafiagangster.blogspot.gr/2012/12/the-superpower-of-crime.html>).

The Russian Mafiya has several important links with the Mossad, the Rothschild family, the Federal Reserve Bank, and with powerful Jewish organizations, such as AIPAC and ADL (source: <https://www.darkmoon.me/2013/the-judeo-russian-mafia-and-the-bloodbath-to-come-by-dr-lasha-darkmoon/>). Thus, there are alarming signs that the Russian Mafiya has taken over the Israeli underworld and is using Israel to launder its vast profits. In fact, it is easy for Jewish mobsters to receive Israeli citizenship, and several non-Jewish members of the Russian Mafiya are smart enough to forge documents in order to become Israeli citizens, since they feel much safer in Israel than in Russia. A wave of mass immigration from the former Soviet Union has brought approximately 750,000 newcomers to the Jewish state between 1988 and 1996. Among the Russian-Jewish immigrants to Israel, there were Russian gangsters, many of whom are believed to have produced bogus proof of Jewish ancestry to enter Israel. The Red Mafiya has invested billions of US dollars in Israel.

Covert operations by autonomous former Nazi networks

The prominent English political analyst and journalist Christopher Story (the pen name of Edward Harle) has analyzed the "European Union collective," and the "penetration of the CIA and its affiliates with the German/Himmler scientists and intelligence officers who were brought over after the de-Nazification program was scrapped in 1946" (source: Christopher Story, "EU Corruption," speech delivered in London: "Lawful Rebellion" Conference, The British Constitution Group, BBC5 TV, October 31, 2009; <http://christopherstory.org/category/in-memori-am-christopher-story/>). Not only did the Germans take over the Western Roman Empire (including the See of Rome) and the British Isles during the Middle Ages and the Hanoverian period, but also, contrary to conventional belief, in World War II, the Allied Powers did not really win the war. According to Christopher Story, the Allies "finished Hitler off," they "personalized the war," and, thus, when Hitler ceased to exist, they thought that they won the war (Ibid). However, that was not the case. In 1941, at the Wannsee

Conference, the Nazi intelligentsia realized that Germany might lose the war, and, therefore, they sent their most intelligent analysts to Madrid, where, in 1942, they set up what they called the “German Geopolitical Center,” whose purpose was to strategize about what would happen if Germany did not win World War II. Thus, the German Geopolitical Center developed a long-range deception strategy that was originally set out in a seminar document entitled “European Economic Community,” published in 1942, in Berlin (source: Christopher Story, *The European Union Collective: Enemy of Its Member States*, London: Edward Harle Ltd, 1997).

After the Second World War, Hans Globke—who had been co-author of the Nuremberg racial laws and of the new laws of the Greater European “Reich” in the countries occupied by the Nazis during World War II—became minister of the Chancellery in German Chancellor Adenauer’s government. Under Chancellor Konrad Adenauer, Globke controlled major aspects of political life in post-war West Germany, from West Germany’s Secret Service to the continuation of the plans of the German oil and drug cartel to conquer Europe through the European Economic Community (EEC), which later became the European Union (EU). Moreover, another prominent Nazi, Walter Hallstein, was a keen advocate of a federal Europe and one of the architects of the European Coal and Steel Community, and he became the first President of the Commission (that is, the executive body) of the EEC (he held the office from 1958 to 1967). Walter Hallstein was a prominent law professor in Nazi Germany, and, on January 23, 1939, he gave a speech on common European law under German leadership, in which he argued that “one of the most important laws [in occupied European countries] is the ‘Protection Law of German Blood and Honor.’”

The Nazis’/Pan-Germanists’ major weapon against Britain is the “European Union collective,” and their major weapon against the United States is the German-Frankish infiltration of the U.S. intelligence network and foreign-policy establishment. According to Christopher Story (Ibid), Henry A. Kissinger, who served as National Security Advisor and later concurrently as Secretary of State in the administrations of Presidents Richard Nixon and Gerald Ford, has played a key role in the penetration of the U.S. intelligence network with a Pan-Germanist ‘fifth column’ and in the substitution of German-Frankish political theories and mentalities, such as *Realpolitik*, for the U.S. Founding Fathers’ ideational principles and goals. In addition, according to Christopher Story (Ibid), Henry Kissinger was instrumental in persuading President Ford to dismiss William E. Colby as the CIA director of intelligence in favor of George H. W. Bush, who was affiliated with the Deutsches Verteidigungs Dienst (German Defense Service), known by the acronym DVD, which is the German ‘black agency’ based in Dachau).

Covert operations by autonomous former Gladio networks

Paramilitary networks, ‘false flag’ operations (i.e., covert military/paramilitary operations designed to deceive in such a way that the operations appear as though they have been carried out by other actors than those who actually planned and executed them), and ‘stay-behind’ operations (in the context of which a country places secret

operatives or organizations in its own territory for use in the event that an adversary may overrun the territory) play important roles in noopolitics.

One of the biggest ‘stay-behind’ operations was Operation Gladio (‘Gladio’ is the Italian form of ‘gladius,’ a type of Roman short sword). Operation Gladio was the codename for a clandestine NATO ‘stay-behind’ operation in Europe during the Cold War. The purpose of Gladio was to maintain paramilitary networks that would continue anti-communist actions in the event of a Soviet invasion and conquest. Gladio operated under different codenames in Italy, Germany, France, Belgium, the Netherlands, Greece, Luxemburg, Great Britain, Norway, Portugal, Spain, Austria, Turkey, Denmark, Switzerland, and Sweden (Daniele Ganser, *NATO’s Secret Armies*, Oxford: Frank Cass, 2005). It was part of a series of national operations first coordinated by the Clandestine Committee of the Western Union (CCWU), founded in 1948, but, after the creation of NATO in 1949, CCWU was integrated into NATO’s Clandestine Planning Committee founded in 1951 and overseen by SHAPE (Supreme Headquarters Allied Powers, Europe). Many of Gladio’s operations were financed and supported by the CIA and by CIA-controlled networks of organized crime and terrorism (Ibid).

Neofascist extremists, such as the far-right Ordine Nuovo subversive organization, and the Italian Masonic Lodge “Propaganda Due” (P2) headed by Licio Gelli executed Gladio’s “strategy of tension” in Italy in the 1960s and the 1970s. Christopher Story, in his book *The New Underworld Order*, writes the following: Licio Gelli, who was also one of the guests at the Inauguration of President Reagan, “was a double agent for the CIA and the KGB, identified by Mark Phillips and Cathy O’Brien as ‘the central figure in Europe and South America that linked the CIA, [the] Masonic Lodge [P2], the Vatican, the ex-Nazis and several South American Governments, the Italian Government, and several international banks” (C. Story, *The New Underworld Order: Triumph of Criminalism*, p. 239; online: <http://exopolitics.blogspot.com/files/the-new-underworld-order-christopher-story.pdf>).

In Italy, Gladio’s “strategy of tension” included the following operations: the 1964 silent *coup d’ état* through which General Giovanni de Lorenzo, who was the head of the Italian SIFAR intelligence agency, forced the Italian socialist ministers to leave the government; the 1969 Piazza Fontana bombing; the 1970 failed coup attempt “Golpe Borghese”; the 1972 Peteano massacre; the 1973 bombing of the airplane Argo 16; the 1974 Piazza della Loggia bombing; the 1978 murder of the then Italian Prime Minister Aldo Moro, who was pursuing the so-called “historic compromise” between the Christian Democrats and Italian Communist Party (PCI); the 1980 Bologna massacre, etc. (Ibid). Through the previous “strategy of tension,” an Atlanticist elite aimed at terrorizing Italian citizens in order to stop the rise of left-wing political forces in Italy and to implement Henry Kissinger’s anti-communist policy, since Kissinger had warned the then Christian Democrat Prime Minister of Italy, Aldo Moro, not to bring all Italian political forces into direct collaboration (source: Arthur E. Rowse, “The Secret U.S. War to Subvert Italian Democracy,” *Covert Action Quarterly* 49 (1994) 20–27, 62–63). In 1978, Aldo Moro was kidnapped and assassinated by the Italian leftist terrorist organization called “Red Brigades,” which worked closely with the Hyperion

Language School in Paris. An Italian police report referred to the Hyperion Language School as “the most important CIA office in Europe” (Ibid).

On October 24, 1990, the then Italian Christian Democrat Prime Minister Giulio Andreotti, who had direct ties with Gladio, publicly recognized the existence of Gladio. On November 22, 1990, the European Parliament passed a resolution (Nr. C 324/201) condemning Gladio. In 2000, a Parliament Commission Report from the Italian political coalition “Gruppo Democratici di Sinistra l’ Ulivo” concluded that the “strategy of tension” had been supported by the United States in order to stop the Italian Communist Party (PCI) and the Italian Socialist Party (PSI) from reaching executive power in Italy (for further details, see: Philip Willan, “US ‘Supported Anti-Left Terror in Italy’: Report Claims Washington Used a Strategy of Tension in the Cold War to Stabilise the Centre Right,” *The Guardian*, June 24, 2000; online: www.cambridgeclarion.org/press_cuttings/us.terrorism_graun_24jun2000.html).

Where do we go from here?

What we have called the “Black-Red International” is the major, global netwar actor in twenty-first century, and, being a global asymmetric threat, it calls for an asymmetric response of unprecedented magnitude and qualities, namely, for a new existential strategy, or a new humanism. By the term ‘netwar,’ we mean a form of low intensity conflict, crime, and activism waged by networked actors, such as transnational terrorists, criminal organizations, activist groups, and social movements that employ decentralized, flexible network structures. The term ‘netwar’ was developed by RAND researchers John Arquilla and David Ronfeldt (see: J. Arquilla and D. Ronfeldt, *Networks and Netwars: The Future of Terror, Crime, and Militancy*, Santa Monica, CA: RAND, 2001).

One cannot defeat the “Black-Red International” by counter-proposing what Zbigniew Brzezinski has called a “permissive cornucopia” (Z. Brzezinski, *Out of Control: Global Turmoil on the Eve of the 21st Century*, New York: Collier, 1993) or just more business. In fact, when U.S. President Calvin Coolidge lightheartedly stated that “the chief business of the American people is business,” he proclaimed an attitude of complacent nihilism and political naivety, which, even unintentionally, eroded civil democracy and facilitated the development and expansion of the “Black-Red International.”

The underlying principles of the aforementioned vitally significant existential strategy, which could pave the way to a new humanism and liberate humanity from both the “Black-Red International” and the corrupt haute bourgeoisie, which, in fact, bred the “Black-Red International,” are delineated by Dr. Nicolas Laos in his book
