it is derived from the following command of Jesus Christ: “be as shrewd as snakes and as innocent as doves” (Matthew 10:16). The distinguishing motto of the **F.S.C.** is the Latin phrase “Vis per Prudentiam et Simplicitas,” which means power through prudence and simplicity-integrity.

In the distinguishing logo of the **F.S.C.**, the ouroboros (a serpent holding its tail in its mouth) symbolizes the power of a new beginning and prudence, the descending dove symbolizes the Holy Spirit’s descent upon humanity, and the eight-pointed Cross symbolizes the eight beatitudes of Jesus Christ’s Sermon on the Mount (Matthew 5:3–10).

Apart from the independent clients who request and buy specific services from the **F.S.C.** on several occasions, the **F.S.C.** maintains an international network of subscribing members who participate in open and closed conferences and educational programs organized by the **F.S.C.** and receive intelligence reports and other services from the **F.S.C.** on a regular basis and according to the degree that each subscribing member has in the **F.S.C.** The subscribing members of the **F.S.C.** are organized into the following four degrees: (i) regular members, (ii) assistant members, (iii) associate members, and (iv) cooperators.
